The fall season is around the corner, and it is an important time of the year to prepare your home for potentially harsh northwest Ohio and southeast Michigan winter weather. If you take the time now to prepare your home, potential problems can be identified before they arise and lead to costly repairs or insurance claims.

Here are some home maintenance tips to help prepare for the coming winter:

INTERIOR

- Have a qualified professional check and clean your heating system on an annual basis.
- Replace the furnace filter according to the manufacturer's instructions.
- Insulate water pipes in areas of your home exposed to freezing temperatures.

EXTERIOR

- Check gutters for damage and make sure they are securely attached to the house.
- Clean gutters and downspouts to keep debris from accumulating. This is especially important during the fall season when leaves tend to collect in gutters.

INTERIOR

- Check and repair caulking around doors and windows that show signs of deterioration.
- Have the chimney cleaned and maintained by a professional.
- Clean the clothes dryer exhaust duct and spaces under and behind the dryer. Remove lint and dust that may have accumulated inside the dryer in accordance with the manufacturer's recommendation. This will prevent a possible fire.
- Check electrical outlets for any loose-fitting plugs or receptacles, and be sure not to overload electrical outlets ... especially with holiday lights!
- Keep a multi-purpose fire extinguisher accessible and make sure it is fully charged.
- Inspect your smoke detectors. Make sure there is one in each bedroom, and in the hallway outside each bedroom. Make sure to have at least one smoke detector on each floor of your home, including the basement. Test them monthly and change the battery annually or as needed.


LIFE INSURANCE CASE STUDY

Bill and Amy are in their early 60s and looking forward to retirement in a couple of years. They own their home, have paid off the mortgage, and have a sizeable nest egg on which to retire. They have one adult daughter - Jenny, age 31, married with a new baby - who earns \$42,000 per year working for a local health care firm. She serves as the family's main breadwinner.

Bill and Amy decided they no longer needed life insurance for themselves as they had no debts, had accumulated a nice nest egg, and their daughter lived on her own. However, Jenny became ill with Lyme disease and was off of work for three months. After that, she could only work part time for the next six months. She decided her only choice was to move herself and baby to live with Bill and Amy while her husband worked. But, when Jenny's husband was injured at work, he was suddenly unable to work in his occupation and provide income for the family.

Bill and Amy discussed their daughter's situation and decided to loan money to Jenny and her husband to help them meet expenses. They even considered taking out a second mortgage on their home to provide their daughter and son-in-law with a deposit to buy their own home before their homeownership dreams died. Bill and Amy both realized they would not be retiring anytime soon as they would need to rebuild their retirement savings.

This situation could have been avoided if Bill and Amy had taken out a life insurance policy for Jenny when she was younger. Over time, the policy's cash value would have accumulated, and Jenny could have borrowed from the cash value. That would have provided a tax-free cash flow for Jenny and her husband to pay the bills. If they had taken out this coverage on their daughter when she was younger, the premiums would have been inexpensive, and Jenny could have assumed responsibility for the premiums when her finances allowed.



THE RECIPE OF THE MONTH!

Stuffed Poblano Peppers



INGREDIENTS:

- 8-12 Large Poblano Peppers
- 1 cup cooked rice
- 1 can black beans
- 2 tablespoons roasted garlic
- 1 (16oz.) package of spicy ground sausage
- 1/3 cup coarsely chopped fresh cilantro
- 1/2 cup red onion, finely chopped
- 1 tablespoon sea salt
- 1 tablespoon cumin
- 1/4 cup finely chopped chipotle peppers in adobo sauce (Embassa is a good brand)
- 1 cup shredded Monterey jack cheese

DIRECTIONS:

- 1. Preheat oven to 350°F.
- 2. Cook sausage until brown and ground into small pieces - add onions and garlic to sauté

for 5-7 minutes.

- 3. While cooking rice and sausage, chop cilantro and chipotle peppers. Cut the poblanos in half lengthwise, taking out the seeds.
- 4. Once everything is cooked, put all but cheese into a large bowl and mix thoroughly. Add cheese and mix again.
- 5. Stuff the poblanos with a spoon and fill them as full as possible.
- 6. Bake on a cookie sheet for 45-60 minutes. (Variation: Cook on the grill on a sheet of foil this may not take as much time, but you will need watch so the stuffing doesn't come out all over the place)
- 7. Serve with salsa, sour cream and more cheese! Note: Left over stuffing is fantastic as part of an omelet or in a burrito.
